Footnotes

NANA'S APPEAL showed speed along the inside into the stretch, then drew off when asked. DAKOTA BOB tracked the pace, was checked soon after entering the turn, raced three wide into the stretch and closed to gain the place. MAN OF FAITH off slowly, chased the pace, made a run to try the winner on the turn, then gave way in the drive. IL DIVO failed to menace after bumping with EX LIBLE at the start. EX LIBLE bumped between rivals at the start, bumped with REX'S DREAM again on the backstretch, was chasing the pace along the rail when caught in tight entering the turn, continued on well into the stretch, then tired. HELICOPTER raced four wide and faltered. REX'S DREAM bumped with EX LIBLE at the start, bumped with that rival again on the backstretch, trailed and was eased in the stretch run.
