WOODRUFF RIDGE quickly sprinted to a clear lead racing off the rail, repulsed a bid from GULF RUCKUS in the stretch, then edged away. GULF RUCKUS tracked the pace along the rail, made a run at the winner leaving the far turn and into the stretch but wasn't good enough. QUIET EMARATI allowed to settle, made a run four wide to loom a threat on the far turn, then gave way. MARCH TWELTH tracked the pace three wide to nearing the stretch, then tired. TOOK IT FROM HIM rated off the pace, steadied from close quarters soon after entering the far turn, then faltered. WINNER JAK showed little. The rider of MARCH TWELTH lodged an objection against the rider of QUIET EMARATI for alleged interference in the stretch and the rider of TOOK IT FROM HIM lodged an objection against the rider of MARCH TWELTH for alleged interference on the far turn. Both claims of foul were not allowed.
