Footnotes

LAST STRIKE showed speed off the rail, responded when challenged by SAINT SPEEDY at the top of the stretch, then drifted out while dueling with that rival and prevailed. SAINT SPEEDY stalked the pace off the rail, eased out and rallied to engage LAST STRIKE at the top of the stretch, then was floated out while dueling for the lead and edged to the wire. ALL ABOUT YASOM showed brief speed, chased the pace four wide around the turn and gave way. GAETANO T showed brief speed, eased back off the leaders racing into the turn, then tired in the drive. BAUMGARTNER showed speed three wide, chased the leader to midway of the turn and faltered. PADDLEYOUROWNCANOE well placed racing along the rail, faded leaving the turn. KAT'S CORINTHIAN broke a step slowly and was outrun. THERE WAS A STEWARDS INQUIRY AND THE RIDER OF SAINT SPEEDY LODGED AN OBJECTION AGAINST THE RIDER OF LAST STRIKE FOR ALLEGED INTERFERENCE THROUGH THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
