ROLLBABY unhurried after being steadied from between rivals at the start, advanced into contention three wide around the far turn, was floated out by SMURF CITY at the top of the stretch, then rallied to catch RUTH WONDERS inside the eighth pole and was fully extended to prevail. RUTH WONDERS stalked the pace, moved through to take over at the top of the stretch when SMURF CITY drifted out, responded when headed by ROLLBABY inside the eighth pole and held on well for the place. MANDATED TO WIN allowed to settle, raced three wide around the far turn and closed to be up for the show. MARIA'S LEGEND reserved early, saved ground around the far turn, eased out and made a run to loom a threat in the stretch, then weakened. LEMON FEVER stalked the pace into the stretch and gave way. PALM BEACH STORY failed to menace. SMURF CITY tracked the pace, rallied to gain the lead on the far turn, then drifted out at the top of the stretch and tired. MALIBU DIVA ducked out at the start and was not a factor. ZOOBARAVA set the pace along the hedge to midway of the far turn, then faltered. DREAMIN OF DIXIE was outrun. REINA SOFIA showed brief speed and faded.
