Footnotes

BROADWAY ACTOR moved up around the first turn to engage RUSSIAN SAGE for the lead, vied with that rival along the hedge into the stretch, then edged away. AUTHORITY RULES outrun early, saved ground into the stretch, angled out for racing room and rallied to be up for the place. SAINT JUDE reserved off the pace, was rallying into contention when he bumped with CAT 'N FIDDLE nearing the sixteenth pole, then didn't do enough late. POWER RULES bumped and steadied from between rivals at the start, moved up quickly to track the pace, made a run to reach contention in the stretch, then bumped with CAT 'N FIDDLE approaching the sixteenth pole and couldn't gain late while finishing on even terms with JUSTIN RULES. The latter, rated off the pace after bumping with POWER RULES at the start, saved ground while advancing to reach contention in the stretch, then flattened out and dead heated with POWER RULES. NINEINTHENINE tracked the pace three wide into the stretch but had no late response. BARBARO'S REVENGE allowed to

settle, raced four wide around the far turn and gained some ground without threatening. RUSSIAN SAGE quickly moved to the fore while racing off the hedge, responded when challenged by BROADWAY ACTOR on the first turn, vied with that rival to the eighth pole, then gave way. DECAF AGAIN bumped with POWER RULES at the start and failed to menace. CAT 'N FIDDLE tracked the pace along the hedge, eased out to make a run at the leaders in midstretch, then was checked when bumped between rivals approaching the sixteenth pole and failed to recover. MR. RICO was not a factor.
