Footnotes

CITIZEN ADVOCATE hit the gate at the start, veered out bumping SANDY KEY GAL soundly in the early going, set the pace under pressure along the inside, then drew off when roused. CECILIA SAYS pressed the pace outside the winner but was no match for that rival in the drive while clearly best of the others. PHOEBE MOON allowed to settle after being bumped hard soon after the start, improved her position in the drive to be just up for the show. SANDY KEY GAL was knocked sideways and into PHOEBE MOON by CITIZEN ADVOCATE soon after the start, recovered to chase the leaders three wide around the turn, then tired. ALONG THE RIVER rated off the pace, raced three wide around the turn and faltered. PA PA PA PERFECT outrun after hesitating at the start, swung wide for the stretch run and never threatened. CHANTY LIGHT was not a factor. PATIENCEISAVIRTUE showed little after hesitating at the start. PEGASUS PEARL reserved off the pace after breaking slowly, faded leaving the turn. Following a stewards inquiry, CITIZEN ADVOCATE was disqualified and placed fourth for interference to SANDY KEY GAL soon after the start.
