LADY IRENE tracked the pace, saved ground around the turn and closed to prove second best while no match for the winner. JALYN tracked the pace three wide around the turn and tired. CALLING NICOLE trailed after hitting the gate at the start and failed to menace. SEA TOW chased the winner off the rail into the stretch and faltered. LIVE WIRE LUCY saved ground to no avail. CAPITAL HONOR was outrun.
