Footnotes

DR. D R chased the pace off the rail, rallied to take over at the top of the stretch, then drew off under urging. NORWICH CADET chased the leaders four wide around the turn, then was no match for the winner while up for the place. MOUNTAIN CHAPEL unhurried early, angled out for the stretch run and passed tired rivals for the show. REDWOOD MAN set the pace, moved to the inside on the turn, made the pace to the top of the stretch, then gave way. FULL OF EXPRESSION chased the pace three wide into the stretch and tired. ABBIR was never a threat after being outrun early. ALICE'S ALEX rated in striking position off the pace after breaking slowly, had no response in the drive. BLACK JACK COUNTY failed to menace. SOUTHERN GROVE showed little. GORDIAN KNOT showed early foot along the inside and faltered. COUNTRY HOME was never a factor. EDGE AHEAD reserved off the pace, was racing five wide when he fell on the turn. There was a stewards inquiry into the fallen horse.
