Footnotes

SKIP COMMAND tracked the pace, angled outside the leaders for the stretch run, rallied to reach even terms for command nearing the eighth pole, then dueled with FAST LISA and just edged that rival to the wire. FAST LISA stalked the pace along the rail, slipped through to reach even terms for command approaching the eighth pole, then dueled with SKIP COMMAND to the wire and just missed. COVINCING stalked the pace, moved to gain a slim lead in early stretch, then weakened. CHANCEY LIGHT rated off the pace, raced three wide on the far turn and closed with a mild response. RIGHT THIS WAY reserved early, saved ground into the stretch and didn't do enough late. BLUE GRASS DANCER set the pace along the inside, came off the rail for the stretch run and gave way. UNBRIDLED SKIP rank under restraint in the early going, failed to menace. INDIANSONG off slowly, was not a factor. P. J.'S ESKIMO outrun early, made a run four wide to get into contention on the far turn, then tired. WICKLOW VAMP tracked the pace three wide into the far turn and faltered.
