**Footnotes**

ROSIE'S PRINCESS reserved early, checked in behind PASSION REDDY on the far turn, angled to the outside for the drive, rallied to take over at the sixteenth pole and won going away. JUST A DREAM broke poorly after she popped open the gate just prior to the start, saved ground around the far turn, angled out and rallied to be up for the place. SILLY CAT rated off pace, made a run three wide on the far turn to reach SYLVIA TWICE, then wore that rival down to be up for the show while being outfinished by the top ones. SYLVIA TWICE set the pace along the hedge, responded when challenged by SILLY CAT on the far turn, maintained a slim advantage to the sixteenth pole, then gave way. PASSION REDDY tracked the pace along the inside, was steadied to avoid running up on SYLVIA TWICE on the far turn, eased out for room at the top of the stretch, made a run to reach the leaders inside the eighth pole,

then weakened. VIBRANT LIGHT tracked the pace into the far turn and tired. LITTLECONCERT tracked the pace four wide to nearing the stretch, then faltered. STAR BITE failed to menace. DEVILINAREDDRESS was not a factor. DESIRABLE DESIREE was outrun. STINGER GAL was never a threat. KIMS WONDER chased the pace, made a run to try SYLVIA TWICE down the backstretch and into the far turn, then was fading when steadied at the top of the stretch. Following a stewards inquiry, JUST A DREAM was declared a non-starter for receiving an unfair start.
