### Footnotes

COUNTY TYRONE set the pace along the inside into the stretch, then responded when challenged by RELIQUARY and held on gamely to prevail. RELIQUARY stalked the pace off the rail, made a run to reach near even terms for command just inside the eighth pole, then tried COUNTY TYRONE to the wire and just missed. KATE MANDY outrun after being steadied at the start, advanced into contention three wide around the far turn, then was gaining on the top ones at the finish to just miss. UNREAL REPLY stalked the pace along the inside into the far turn, then tired. SHE'SJUSTBUSINESS rated off the pace, faltered on the far turn. NENA'S FOREVER tracked the pace for a half mile and faded. SECRETARIAT INDY showed early foot along the inside, then had nothing left.
