**Footnotes**

EASTERN SEABOARD rated off the pace, raced four wide around the far turn, rallied to catch CONRAD CROSSING inside the eighth pole and was fully extended to prevail. CONRAD CROSSING reserved off the pace, rallied to take over on the far turn, made the pace to past the eighth pole, then couldn't stay with the winner while continuing on with good courage for the place. TOMS MULLIGAN tracked the pace along the hedge, eased out and made a run to loom a threat in the stretch, then gave way. TIMELESS SANDS well placed in behind the leaders, advanced three wide around the far turn to reach contention, then tired in the drive. MIDATLANTIC hesitated after hitting the gate and popping it open just prior to the start, was outrun into the far turn, then improved his position in the drive. LIMONADA raced in striking position into the stretch but had no response when asked. VICAR IN THE HOUSE failed to menace after being checked from tight quarters in the early going. LEONARD G set the pace along the hedge into the far turn, then faltered. HIGHER APPEAL was outrun after being checked from between rivals soon after the start. RING THE REGISTER chased the pace into the far turn, then faded. DE

LEON was no factor after being steadied in the early going. THEY CALL ME ZIGGY showed little after being caught in tight early. There was a stewards inquiry into the start. No action was taken.
