Footnotes

BLUESY CAT stalked the pace, was steadied entering the turn, continued to stalk the pace along the rail, rallied and slipped through inside DONDE ANDAS to gain the lead just past the eighth pole, then was fully extended to prevail. LIL JOHN PAUL stalked the pace off the rail, eased out and made a run to reach near even terms for command at the eighth pole but was outgamed to the wire. COMMANDER TATE steadied briefly on the backstretch, moved up to race in contention three wide around the turn, then responded to pressure in the drive and was gaining on the top ones. PAPPA'S HOME allowed to settle, raced three wide around the turn, angled out for the drive and finished willingly. DONDE ANDAS quickly moved to the fore, made the pace along the inside, came out a bit for the stretch run while maintaining his advantage to the eighth pole, then gave way. FULL OF EXPRESSION rated off the pace, saved ground into the stretch and had no response when asked. ROYAL CRIMSON stalked the pace into the stretch and tired. POSITIVE ACTION raced four wide and failed to menace. GASPAR was not a factor. GUIDING SPIRIT was outrun. GREAT RYAN broke poorly, moved up quickly down the backstretch to reach contention, then faded.
