MARCH TWELTH quickly moved to the fore along the rail, repulsed a bid from SCORION leaving the far turn and was fully extended to prevail. TAXES TAXES stalked the pace along the inside, eased out for the drive and couldn't get to the winner while up for the place. SCORION chased the pace, made a run at the winner on the far turn, then weakened in the drive. SURELY SENT rated off the pace, eased out for the drive while moving into contention but didn't do enough late. MORGANS BOY reserved off the pace, raced four wide around the far turn and gained some ground without threatening. UNBRIDLED FUTURE stalked the pace three wide to the top of the stretch, then tired. WISE ESCAPE unhurried after being caught in tight at the start, was no factor while racing five wide. MOUNT SKYLIGHT was outrun while saving ground. SWINGMAN raced in striking position to nearing the stretch, then faltered. HOLD MY CALLS was done early.
