PUT IT ON A JET chased the winner off the rail into the stretch but was no match for that rival while continuing on with good courage for the place. DEVILISH LADY reserved early, improved her position in the drive to be up for the show while no threat to the top ones. SNOW TRIAL chased the leaders along the rail into the stretch, then tired. GREATEST DREAM broke awkwardly, tracked the leaders three wide around the turn and faltered. VENCEDORA GIRL was outrun.
