HUMMEL sprinted to a clear lead while angling over to the inside, then increased her margin through the stretch under a strong hand ride. THEMUS unhurried after breaking slowly, angled out for the stretch run and closed to be up for the place. TRAIL RIDER checked in behind HUMMEL in the early going, chased that rival into the stretch and tired. PENTERA chased the leaders three wide around the turn and faltered. ROBYNSRULES off slowly, was never a factor. SILO broke poorly, then ducked in soon after and was outrun. SAVVY GIRL raced three wide on the turn and faltered. CALLMEBRANDY rated in striking position off the pace, faded in the drive. SORRYFORYOURLUCK steadied when caught in tight on the backstretch and was outrun. The rider of TRAIL RIDER lodged an objection against the rider of HUMMEL for alleged interference in the early going. The claim of foul was not allowed.
