IMAGE OF A CAT reserved early, saved ground into the stretch, angled outside the leaders and rallied under pressure to be up late. VICTORIOUS RECALL vied for the lead along the inside into the stretch, then held on well for the place while being edged to the wire. FIRST TOUR vied for the lead outside VICTORIOUS RECALL to inside the eighth pole and weakened. CONCORDE'S APPEAL rated off the pace, raced three wide around the turn and lacked the needed late response. DAN'S REPORT was not a factor. STORM BANK up close early, raced four wide around the turn and tired. FABULOUS FORTUNE was outrun after breaking slowly.
