LAWYER JEN away alertly, quickly sprinted well clear racing off the rail, made the pace to deep stretch but couldn't resist the winner while clearly best of the others. MY FRIEND ROSSARIO broke poorly, tracked the pace along the rail into the stretch but didn't do enough late. MIZZEN THE RHYTHM was never a factor. HONOR WITH ROSES was outrun while racing four wide. MY ESPRESSO chased the winner three wide into the stretch, then tired.
