### Footnotes

CINNAMON ROAD set the pace along the inside, drew clear in the stretch, then was fully extended to last over MR SUPER LIFT. The latter, stalked the pace along the inside, eased outside CINNAMON ROAD in the stretch and rallied to just miss catching that rival. CHRISTMAS PARADE stalked the pace into the stretch, responded to pressure in the drive and was gaining on the winner at the finish. MORGANS BOY failed to menace. STING BOY was not a factor. MEDAGLIA D'ONORE stalked the pace three wide to midway of the far turn, then tired. SILVER EAGLE was outrun.
