**Footnotes**

SLAM FIRE set a pressured early pace, moved away under rating a half mile out, continued well in front four wide under confident handling in mid stretch, drifted out late and proved much the best while under mild hand urging. WAIKIKI , taken to rate early, advanced between rivals near the half mile marker, made a solid four wide into the stretch and continued on willingly. EXUBERANT SONG , under restraint early while saving ground, angled four wide advancing into the stretch, shifted in past the eighth pole but needed more late. MEASURE UP lacked speed, saved ground into the lane, angled out in mid stretch and had some belated action. L. G.'S FLASH , three wide, failed to menace. SLIVER SABRE lacked speed, came wide for the drive and could not threaten. ALYSON'S APPLE stalked two wide inside a rival and gave way. THE PARTY'S OVER , four wide chasing the pace, gave way. ANGEL DEL CIELO chased briefly while between rivals and faltered. PETER BOY pressed the early pace outside the winner, chased around the turn, dropped back and shifted in through the drive.
