TRI TO DANCE chased the pace, moved to take over on the far turn and edged clear but couldn't hold off the winner in the final strides. APPEALING RUNNER unhurried early, angled out for the stretch run and closed well for the show. MEREDITH failed to menace. WALKINFORKISSES was not a factor. PARK TAVERN chased the pace three wide, made a run to try for the lead on the far turn, then tired in the drive. FANCY STEPPER set the pace along the rail into the far turn, then faded.
