### Footnotes

SILK RIDGE checked from tight quarters in the early going, tracked the pace three wide, rallied to take over at the eighth pole and edged away. CALICO BAY allowed to settle, advanced into contention around the turn, then rallied to be up for the place while unable to get to the winner. BOND PRINCESS reserved after being steadied when she bumped with HER GREATNESS in the early going, saved ground around the turn, made a run to loom a threat in midstretch, then flattened out. BEN'S TUNE forced in soon after the start, advanced four wide around the turn, joined the leaders in midstretch, then weakened. ARIEL BRIGHT drifted in early contributing to crowding, moved up to vie for the lead outside TRUE WILL around the turn, continued on with good courage to inside the eighth pole, then tired. CRIMSON ORE chased the pace around the turn and faltered. HER GREATNESS was no factor after bumping with BOND PRINCESS and being steadied in the early going. TRUE WILL vied for the lead along the rail to the top of the stretch, then faded.
