### Footnotes

TEN PAST TEN reserved off the pace after breaking slowly, swung out for the stretch run, rallied to gain command in early stretch, then drew off under urging. D' NEXT EXPERIENCE chased the pace off the rail, moved to gain a brief lead entering the stretch but was no match for the winner while holding the place. TURBO CANNON chased the pace along the inside, eased out for the drive, then bumped with STARSHIP SULU nearing the eighth pole and closed to gain the show. INDIRECTLY A. P. tracked the pace three wide into the stretch and gave way. SOUTH SLEW off slowly, was never a factor. STARSHIP SULU showed speed along the inside, then tiring when he bumped with TURBO CANNON nearing the eighth pole and continued to drop back. GURI rated off the pace after breaking slowly. GHOST PEPPER stumbled soon after the start and was outrun. There was a stewards inquiry and the rider of STARSHIP SULU lodged an objection against the rider of TURBO CANNON for alleged interference in the stretch. The claim of foul was not allowed.
