Footnotes

ARNELY (ARG) chased the pace, angled to the inside entering the turn, rallied to gain command in early stretch, then drew off under urging. FAITHFUL PRAYER reserved off the pace, raced three wide around the turn and closed to prove second best while no match for the winner. YOLANDA'S DREAM tracked the leaders off the rail around the turn and tired. INSIDE DEAL raced three wide and failed to menace. BELIEVEINTHEMOMENT was not a factor. DAZZLING HALO sprinted to a clear lead while racing three wide, increased her advantage around the turn, then hand nothing left for the drive. SITTTIN' ON GOLD was chasing the pace along the rail when checked entering the turn, then faded. There was a stewards inquiry and the rider of SITTTIN' ON GOLD lodged an objection against the rider of ARNELY for alleged interference entering the turn. The claim of foul was not allowed.
