DOC GREEN unhurried early, raced four wide around the turn, rallied to gain the lead inside the eighth pole and was fully extended to prevail. UNIVERSAL EXPRESS tracked the pace off the rail, bumped twice with SOULFULLY in midstretch, then closed to just miss catching the winner. MASSECUITE reserved off the pace while racing three wide, was angled to the inside on the turn, then angled out widest of all in the stretch and rallied to just miss catching the top ones. IM GOOD AT THAT dueled for the lead along the inside to deep stretch and weakened. SOULFULLY rated off the pace, advanced three wide around the turn to reach contention, then bumped twice with UNIVERSAL EXPRESS in midstretch and couldn't gain late. FABULOUS TEXAS outrun early, rallied along the inside to reach contention in the stretch, then didn't do enough late while lacking room inside IM GOOD AT THAT. SMART COLE dueled for the lead outside IM GOOD AT THAT into the stretch, then faltered. The rider of FABULOUS TEXAS lodged an objection against the rider of IM GOOD AT THAT for alleged interference in deep stretch. The claim of foul was not allowed.
