### Footnotes

DIXIE MATT stalked the pace, eased out and rallied to gain the lead at the eighth pole, edged clear at the sixteenth pole, then was all out to just last over SERAPI CAT. The latter, reserved off the pace, eased out in the stretch and rallied to just miss. SIGMONDO unhurried early, raced three wide on the far turn, angled out for the drive and closed well for the show. CHAZMULE outrun early, finished willingly without threatening. MARCH TWELTH quickly sprinted to a clear lead while angling over to the rail, responded when headed by OFFICER'SGENTLEMAN on the far turn, vied for the lead to inside the eighth pole, then gave way. JUSTIN RULES rated off the pace, saved ground and had no late response. NOTE TO HARRY chased the pace along the inside into the stretch, then tired. OFFICER'SGENTLEMAN chased the pace, made a run to get a slim lead on the far turn, vied with MARCH TWELTH to inside the eighth pole, then faltered.
