BOUND TO BLUSH pressed the pace into the stretch, then drew clear under steady urging. RESTLESS RUCKUS set the pace under pressure into the stretch but couldn't stay with the winner while holding the place. LEAH'S SILVERADO chased the pace four wide into the stretch and weakened. SMILIN VIGGIE well placed around the turn, tired in the drive. ANGELA'S TUNE chased the pace three wide to midway of the turn and faltered. BLACK SERAPHIM was outrun. SIBERGACE showed little. The rider of ANGELA'S TUNE lodged an objection against the rider of LEAH'S SILVERADO for alleged interference on the turn. The claim of foul was not allowed.
