Footnotes

SOUTH FORK LODGE settled well back saving ground, lacked room at the heels of the waning Wingedlie through the final turn, forced his way outward entering the stretch and closed steadily to get up the final jump. B L'S WHO'S WHO rated the pace inside, was urged away through the stretch then outfinished the final stride. LUNAR FLEET, pinched back at the start, moved to the outside into the opening turn, rated off the pace on the backstretch, closed six wide on the final turn and gained well to late stretch before running out of ground. MORGANS BOY, unhurried off the rail, lacked room through the final turn, was carried out at the top of the lane and closed well in the drive. GALLOPING THUNDER stalked the pace while off the rail, threatened the pacesetter through the final turn then gave way in the stretch. TANGO RIDGE rated off the pace off the rail, bid into the final turn but showed no further response in the stretch. CHAMP DE MARS, off the pace toward the outside, bid five wide on the final turn then weakened in the stretch. WINGEDLIE rated just off the pace inside, picked up the chase toward the final turn and gave way in the stretch. BRONX BULL rated off the pace about the three path but had no response on the final turn. LECTUS was never a factor. After reviewing a claim of foul against the winning rider, lodged by the rider of Lunar Fleet for an infraction leaving the gate, the stewards declared this race official without change.
