### Footnotes

SKY VENTURE set the pace along the inside, responded when challenged by SMOKING THE FIELD at the quarter pole, then dueled with that rival to deep stretch and prevailed. SMOKING THE FIELD stalked the pace off the rail, moved up to engage SKY VENTURE at the quarter pole, dueled with that one to deep stretch and was being outgamed to the wire when he tried to savage that rival in the final stride. MY SAINT reserved off the pace, swung out for the stretch run and closed to gain the show while no threat to the top ones. CAPT. ZIPPOUNAS stalked the pace along the inside to the top of the stretch, then tired. YELLOW BRICK ROAD rated off the pace, raced three wide around the far turn and faltered. LEFT WING WACKO allowed to settle, raced four wide around the far turn and faded.
