MUCHO MAS MACHO , nudged along in range and off the rail, moved between rivals into the lane, angled out to about the four path, closed under left handed encouragement, forged ahead about sixty yards from the wire and proved best. TELL TALE FRIEND held a clear lead near the three quarter pole, was joined in early backstretch, dueled under strong urging, held a short lead two wide into the lane, met the challenge of the winner nearing the sixteenth marker and stayed on well. BROTHER PAT , under a snug hold early while saving ground, got through and made a bid in mid stretch but wasn't quite good enough. STAR OF SARAVA moved to challenge near the five furlong pole, dueled between rivals into the lane and faded. BURNING TIME saved ground early, angled out leaving the far turn, made a mild five wide run approaching the stretch but failed to sustain. MIDNIGHT SERENADE , unhurried early, swung wide and had some belated action. LET'S CALL A TRUCE , three wide, dueled from the five eighths pole to the quarter pole and faltered.
