**Footnotes**

BELLA BELLA bumped hard with R TRUE LADY at the start, vied for the lead to midway of the turn, drew well clear in the stretch, then was fully extended to hold SEA BIRDIE safe. The latter, reserved along the inside, steadied in traffic at the top of the stretch, eased out and closed well for the place. STORMEY WONDER rated off the pace after breaking slowly, advanced to loom a threat in the stretch but couldn't gain late. BLUSHING TIGER allowed to settle, angled out in the stretch and found her best stride late. STORMY DEEDS vied for the lead three wide to midway of the turn, then couldn't stay with the winner and gave way in the drive. MAIN STREET GIRL saved ground and failed to menace. R TRUE LADY bumped soundly with BELLA BELLA at the start, tracked the leaders five wide around the turn and tired. SPLIT THE CLOUDS raced with the pace four wide into the turn and faltered. HONEY OF A DREAM was outrun. BOBBIESQUEEN away alertly, quickly angled over to the rail, showed speed into the turn, then faded.
