PEEKABLUE SUE reserved racing off the rail, rallied to take over at the sixteenth pole, then was all out to last over A LITTLE OFF. The latter, rated off the pace, angled three wide on the far turn and rallied to just miss. WITCH'S ORCHARD set the pace along the rail, drew clear down the backstretch, made the pace to the sixteenth pole, then came out a bit while giving way. DESTINY JOY stalked the pace into the stretch, then was caught in traffic late and couldn't gain. PYRITE SMOKIN failed to menace. SWEET AND VICIOUS chased the pace along the inside into the far turn and tired. KNOCKINELDER stumbled badly at the start, rushed up to reach contention on the first turn, then faded soon after. THE RIDER OF DESITNY JOY LODGED AN OBJECTION AGAINST THE RIDER OF WITCH'S ORCHARD FOR ALLEGED INTERFERENCE IN LATE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
