SUGAR N SPICE vied for the lead outside CRIMSON NATIVE, responded when headed by LARK'S IMPRESSION in midstretch, then drew off under urging. DEMA DEMA DANCER well placed while saving ground, eased out for the stretch run and closed to be up for the place while no threat to the winner. VAGUE MEMORY tracked the pace four wide into the stretch, then couldn't gain on the top one late while just missing the place. LARK'S IMPRESSION chased the pace three wide around the turn, rallied to gain a slim lead in midstretch, then gave way abruptly. CRIMSON NATIVE vied for the lead along the rail into the stretch and tired. ABUELA ESTHER (URU) turned in a dull effort after breaking slowly.
