D'NIED PERMISSION reserved off the pace, angled out for the stretch run, then rallied to catch TWO T'S AT TWO B inside the sixteenth pole and lasted over JOSHUA'S COMPRISE. The latter, outrun after ducking in at the start, angled out for the stretch run and rallied to just miss catching the winner. TWO T'S AT TWO B pressed the pace three wide, moved to take over midway of the turn, opened a clear lead in the stretch but couldn't resist the top ones late. L'S TICKET TO RIDE unhurried early, gained ground late along the inside without threatening. BILLOS BOY failed to menace. DIXIE HIGH set the pace under pressure off the rail to midway of the turn, then couldn't stay with TWO T'S AT TWO B and tired in the drive. G. T. TABU rated off the pace, faltered.
