DIABLO'S CHOICE chased the pace, was moving to take over at the top of the stretch when his rider lost his whip, then was under a steady hand ride to prevail. GOOD CONCERTO well placed after breaking slowly, angled out in midstretch and was gaining at the finish. SWAMPY broke to the inside, moved up to set the pace along the inside and weakened in the drive. DON RON steadied at the start, raced three wide on the turn and lacked a late response. MYSTIC'S FORTUNE was no threat while racing three wide. BEQUOIT was outrun. WESTERN PRIDE showed speed along the inside and faltered. NO OSCAR wheeled at the start and was pulled up. The rider of DON RON lodged an objection against the rider of SWAMPY for alleged interference at the start. The claim of foul was not allowed.
