SMILIN' N BLUSHING unhurried early, raced four wide on the far turn, then rallied under a strong hand ride to take over at the sixteenth pole and prevail. JELLY FISH vied for the lead outside GRAND VERANDA into the stretch and continued on gamely for the place while being outfinished. GRAND VERANDA vied for the lead with JELLY FISH along the hedge to inside the eighth pole and weakened while finishing on even terms with CYBIL. The latter, reserved off the pace, angled out at the top of the stretch and closed to dead heat for the show. PEER REVIEW stumbled at the start, saved ground throughout and had no response when set down for the drive. DIANA MY LOVE stalked the pace three wide, was steadied when caught in tight between SMILIN' N BLUSHING and CYBIL at the top of the stretch, then tired. The rider of DIANA MY LOVE lodged an objection against the rider of SMILIN' N BLUSHING for alleged interference at the top of the stretch. The claim of foul was not allowed.
