### Footnotes

YELT tracked the pace three wide, rallied to gain command at the top of the stretch, then drew off under urging. LIVE ACTION unhurried after being caught in tight on the backstretch, swung out for the stretch run and closed to be up for the place while no match for the winner. SMASHIN THRU chased the pace around the turn and tired. TO MONARCH set the pace off the rail to the top of the stretch, then faltered. SLICED N DICED was outrun. UNBRIDLED HEAT hit the gate at the start, moved up to prompt the pace along the rail to past midway of the turn, then faded.
