Footnotes

CANAIMA chased the pace, moved to take over racing down the backstretch, made the pace off the rail, then drifted out in midstretch while repulsing a bid from GREATEST DREAM, was straightened away and increased her margin to the wire. GREATEST DREAM stalked the pace three wide, made a run outside CANAIMA to reach that rival in midstretch but couldn't stay with that one while holding the place. LADY S unhurried early, advanced into contention around the far turn and into the stretch but couldn't gain on the winner late. SWEET LIL CHEROKEE rated off the pace, raced three wide around the far turn and tired. PERFECT BERRY was through after a half mile. HALO JEZABELLE set the pace, drifted out on the backstretch losing the lead, then continued to drift out around the far turn and faded. THERE WAS A STEWARDS INQUIRY AND THE RIDER OF GREATEST DREAM LODGED AN OBJECTION AGAINST THE RIDER OF CANAIMA FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
