BETTARUN FAST chased the pace three wide, moved to gain command leaving the turn, then drew away under urging. LITTLE RIGHT DOVE unhurried early, angled out for the stretch run and closed to be up for the place while no match for the winner. ROAD TRACK'S JOY chased the pace into the stretch, then weakened. LOVE BOOT reserved after breaking slowly, saved ground and passed tired rivals. SOUTHERN FORTUNE tracked the pace into the stretch and gave way. TIME BANSHEE vied for the lead outside FLAWLESS GEM to nearing the stretch, then tired. DAYLIGHT TIME off slowly, raced three wide and failed to menace. FLAWLESS GEM vied for the lead along the hedge to nearing the stretch, then faltered. PONDSIDE bumped with NO HEAR SAY at the start, raced three wide around the turn and faded. DOUBLE BRISTOL raced five wide and was done early. NO HEAR SAY bumped with PONDSIDE at the start, raced four wide on the turn and stopped. SIS B. CHOICE trailed after breaking poorly.
