TAKEMDOWN chased the pace four wide, rallied to take over in early stretch, then drew clear under urging. BIG MOUTH chased the pace along the rail, dropped back racing around the turn, came on again to reach near even terms for command at the eighth pole but couldn't stay with the winner while proving second best. PRESENTLY showed speed off the rail, drew clear on the turn, then gave way in the drive. ANY GOOD LAWYER chased the pace three wide around the turn and tired. HERMAN'S SOLDIER rated off the pace, faltered in the drive. WAYKOOKEVAN was outrun. ON THE SPOT was not a factor. QUAD'S DOUBLE was done early.
