THUNDER BABE showed speed outside REGAL ENDORSEMENT, then drew away through the stretch under pressure. REGAL ENDORSEMENT showed speed outside BLUE CHIEF, angled in entering the turn bumping that rival soundly, then was no match for the winner in the drive while holding the place. CHARUTE unhurried early, passed tired rivals for the show. BLUE CHIEF was showing speed when bumped by REGAL ENDORSEMENT and forced to check entering the turn, saved ground into the stretch and tired. NEW YORK JESSICA was racing close up along the rail when caught in tight and taken up entering the turn, then failed to recover. DOUBLE CHOICE chased the leaders three wide around the turn and faltered. TIPPER KELLY M. D. off a step slowly, was outrun while racing four wide. FRESQUITA reserved racing off the rail, faded leaving the turn. Following a stewards inquiry and a claim of foul by the rider of NEW YORK JESSICA against the rider of REGAL ENDORSEMENT, REGAL ENDORSEMENT was disqualified and place fifth for interference to both NEW YORK JESSICA and BLUE CHIEF entering the turn.
