Footnotes

JUSTANOCEANAWAY set the pace off the rail into the stretch, then edged away under pressure. SCORE BOYERA rated off the pace advanced along the inside leaving the backstretch, was steadied when unable to get through inside JUSTANOCEANAWAY on the far turn, eased out to chase that rival into the stretch but couldn't stay with that one while clearly second best. GORGEOUS MELODY stalked the pace three wide to nearing the stretch, then tired. SNOW TRIAL was not a factor. ZEFFEE well place for a half mile, faltered. DELIGHTFUL DAWN stalked the pace off the rail into the far turn and faltered.
