ASSET EXCHANGE vied for the lead between horses, moved to the inside when GO ZAPPER dropped back on the turn, continued to vie with GIBSON COUNTY LINE to nearing the eighth pole, then drew clear under urging. GIBSON COUNTY LINE vied for the lead outside ASSET EXCHANGE to nearing the eighth pole, then couldn't stay with that rival while holding the place. TURBO CAT reserved racing along the rail, was checked leaving the backstretch and again soon after entering the turn, swung out for room midway of the turn, then rallied for the show. GO ZAPPER vied for the lead along the rail into the turn and gave way. CZARDOM off slowly, tracked the leaders three wide around the turn, then tired. AZUL COAST failed to menace. FOOLISH TIGER was not a factor. B J'S GIBSON was taken up entering the turn to avoid running up on NICKEL MILLIONAIRE and never threatened. I'MANOTHERBROTHER was outrun after breaking poorly. NICKEL MILLIONAIRE tracked the pace into the turn, faded and was eased in the stretch run. THERE WAS A STEWARDS INQUIRY INTO THE INCIDENT ENTERING THE TURN. NO ACTION WAS TAKEN.
