STORMY DEEDS chased the pace along the inside into the stretch, angled outside BELLA BELLA and rallied to be up in the final strides. BELLA BELLA showed speed off the rail to deep stretch but couldn't resist the winner while holding the place. BLUSHING TIGER off slowly, saved ground around the turn, angled out and rallied to be up for the show. HAWAIIAN CRUISE pressed the pace three wide around the turn, then gave way. MAIN STREET GIRL was outrun. JOYFUL BIRD well placed early, raced three wide around the turn and faltered.
