**Footnotes**

CUT FOR LUCK stalked the pace after bobbling at the start, rallied to gain command in early stretch, then drew away under pressure. BULLET DEJOUR rated off the pace, closed to be up for the place while no match for the winner. BLUSHING BAVARIAN set the pace along the rail into the stretch, then tired. SOME TOMBOY unhurried early, improved her position without threatening. SAN MICHELE was not a factor. GLITZY GLIDER tracked the pace three wide into the far turn, then faltered. MAY MAY'S GUMBO tracked the pace into the stretch, then faded. SHIMMERING LAKE off slowly, was outrun.
