

SORBET rallied, four deep around the turn, and was up in the final strides while being kept to pressure. WILDCARD CAT set the pace off the rail and gave way late. CLEARLY A. K. O. bumped hard with SPECIAL REPORT and knocked sideways on the backside, then rallied to gain the show. NEW STORM chased the pace, three wide around the turn, then weakened in deep stretch. SPECIAL REPORT bumped hard with CLEARLY A. K. O. on the backstretch and steadied, raced four deep on the turn and rallied mildly. SUCHATOUCH rated off the pace along the inside and finished evenly. SIMPLY FANCY steadied at the start, then again leaving the turn and faltered. There was a stewards inquiry into the incident on the backstretch. No action was taken.
