COUNTY TRICK set the pace under pressure racing off the rail, then drifted out through the stretch while drawing away. WAIKIKI reserved early, was knocked into TARZANITO nearing the end of the backstretch, raced three wide around the far turn, then closed to be up for the place while drifting to the inside. WIRELESS MACHO moved up on the backstretch to press the pace along the rail into the stretch, then gave way. ROCKCASTLE was tracking the pace when steadied in behind the leaders on the backstretch, came out bumping WAIKIKI nearing the end of the backstretch, then tired. RITMO CRIOLLO pressed the pace outside COUNTRY TRICK to nearing the far turn, then faltered. TARZANITO was tracking the pace when bumped soundly by WAIKIKI nearing the end of the backstretch, then faded. SARAVA STAR was done early. THERE WAS A STEWARDS INQUIRY INTO THE BUMPING INCIDENT ON THE BACKSTRETCH. NO ACTION WAS TAKEN.
