Footnotes

HAP E TO RUN pressed the pace three wide around the turn, moved to take over in early stretch, then drew away under urging. SEND JOYCE tracked the pace, angled out for the drive and closed to be up for the place while no match for the winner. POINT TO PONDER showed speed along the rail to nearing the quarter pole, then gave way. VAL'S GOLD showed speed between horses, continued to contest the pace into the stretch, then tired. OH SO CYBIL off slowly, saved ground and failed to menace. CHATTIN CAT chased the pace after breaking poorly, then clipped heels with HAP E TO RUN entering the turn impeding several rivals and faltered. YIMC SWORD showed early foot, steadied entering the turn and dropped back. RAHY RIDGE unhurried early, checked soon after entering the turn and was not a factor. WISHFUL WOMAN allowed to settle, checked on the turn and was never a threat. PERFECT MARRIAGE well placed early, was taken up to avoid CHATTIN CAT on the turn and faded. There was a stewards inquiry into the incident on the turn. No action was taken.
