STATUTORIAL pressed the pace outside BANZAI KID, took over from that rival leaving the turn and opened a clear lead, then was under urging to remain clear to the wire. CITY OF WESTON rated off the pace after being steadied from close quarters at the start, raced three wide around the turn, angled out and rallied to prove second best. LAW REVIEW tracked the leaders along the inside into the stretch, then couldn't keep pace with the top ones while gaining the show. MOONLIT PARK off slowly, failed to menace. BROKEN LEGACY was no factor while racing three wide. BANZAI KID showed speed along the inside to nearing the top of the stretch, then tired. ARTIE OCEAN well placed early, faltered. SILVER SEARCH broke awkwardly, was chasing the pace three wide when steadied to avoid bearing out on the turn and faded. DUPPYZAPPER off slowly, trailed.
