COUNTY SLIP showed speed along the inside into the stretch and was fully extended to hold off DOUBLE DECKER. The latter, chased the winner off the rail into the stretch but couldn't gain on that rival while saving the place. PURELY GUILTY chased the pace along the inside, was steadied on the turn to avoid running up on the leader, then finished willingly to just miss the place. FAVORITE SLAM off slowly, moved up quickly to chase the pace three wide into the stretch and gave way. PACK ATTACK failed to menace after being checked at the start. MEMORYS N DREAMS raced along the rail and trailed.
